Derived from Department of Consumer and Business Services Employer Data System report, manual counts prior to 1977. 2000-2005 data revised due to change in methods that counts Oregon policies only.
- ² Workers' compensation subject employment estimate was derived from data provided by the Oregon Employment Department Quarterly Census of Employment and Wages, U.S. Bureau of Labor Statistics Current Employment Survey, Oregon Department of Human Services, City of Portland (Fire and Police Disability & Retirement Fund), and Pacific Maritime Association.
- ³ For 1968-1973, includes all claims filed, as shown on the Workers' Compensation Board monthly reports; data after 1973 are estimates based on several sources. Data from 1994-present data have been revised due to change in estimation methodology; estimates may change over time.
